

HOW TO SUCCESSFULLY NAVIGATE THE NEW FERC SECURITY PROGRAM FOR HYDROPOWER PROJECTS

- ✓ Discussion of the proposed security program changes, including a Q&A session
- ✓ Instruction on providing comments to the FERC
- ✓ Course summary and review.
