Dear Speaker Ryan, Minority Leader Pelosi, Chairman Brady and Ranking Member Levin:

The National Hydropower Association ("NHA"), the American Biogas Council ("ABC"), the Biomass Power Association ("BPA"), and the Energy Recovery Council ("ERC") strongly urge you to take immediate action to extend the expiring renewable energy tax incentives for our industries.

Time is running out as our incentives will lapse at the end of this year. Every day that passes without an extension increases the uncertainty for project developers in our industries and creates a further negative economic market signal to the investment community.

The looming expiration also puts our industries at a significant competitive disadvantage with wind and solar projects with which we compete in bidding on State-level Requests for Proposals for renewable electricity, particularly now that they have the certainty that their tax incentives will be in place over a longer term.

The end result – less reliable renewable baseload power will be deployed, which we believe is not the intent or desire of Congress and not in line with an all-of-the-above energy strategy. We look forward to working with you and your staffs on a solution that provides our industries the policy certainty that others currently enjoy and are benefitting from.
